



> RULES AND REGULATIONS OF THE "SRI ANKALREDDY MEMORIAL EDUCATIONAL ASSOCIATION"

1. Name of the Association: The Sri Ankalreddy Memorial Educational Association, Allagadda.

A. Location for the present: -H.No.7-1-60 Nehru Nagar, Allagadda-518 The Association is run by the Governing body consists of 7 members etc., One water President, One Vice President, One Secretary, One Joint Secretary, One Treasurer and Two members.

- 2. It will in have a General Body constituted by ordinary members.
- 3. The sole responsibility of running the Degree College and in fulfilling the aims and objects of Association vests only with the Governing Body.
- 4. If any member of the Governing Body resigns of ceases to be a member by reason of his physical in capacity or otherwise, or de ath, his place is to be filled up from among the heirs of the so resigned or deceased member. Any member fails to attend the meeting consiqutrely for meetings he is ceacs to be members.
- 5. In the event of any heir of the deceabed member or resigned member refuses or declines to accept the position in the Governing Body due to disaclination or dissatisfaction, such a vacancy can be filled up by any heir of the other Governing Body members Subject to approval of the majority of the remaining Governing Body members by voice vote.
- 6. Apart from the Governing Body members no other member, Whether he is a contributor or doner to the establishment or improvement of the Association or college, can have any right to franchise his vote in any form in the affairs of Association.

- 7. a) Governing Body: Shall have full control and responsibility of the Association and the Degree college in running it properly. The Principal of the College and other staff members are fully to cooperate with the Governing Body for the smooth running of the Institution and to fulfill the aims and objects of Association.

 - f) The quorum for the Governing Body shall be 4(four) the quorum for the General body will be 3/5its on the roll.

8. PRESIDENT:

-) The Governing Body shall elect by voice vote a president for m among its members.
- b) The President so elected shall be the Presiding Officer of all the meetings of the Governing Body.

He will function as presiding Officer in the absence of the President in any meeting of the Governing Body when both President and Vice President are absent any one of the Members of the Governing Body can be elected to preside over a particular meeting.

10. SECRETARY:

He shall be the executive Officer of the Association to grant proper receipts for all the Financial income and to obtain Vouchers for all the expenditure. All correspondence relating to the Association shall be done by him.

- b) The moneys deposited shall be in a joint account of the Treasurer and Secretary.
- c) Moneys can be drawn from the Bank according to the directions of the Financial sub-committee or the Governing Body by the joint signatures of both treasurer and secretary.
- d) The Treasurer can keep k. 100/-in his personal account for contingent expenditure.

12. JOINT SECRETARY:

- a) He shall function as Secretary in the absence of Secretary.
- b) He shall be responsible for all the inventory of furniture and stores. A Register should be properly maintained for all the inventory of furniture.

19. Amendments:-

(1) No amendment or alteration shall be made in the byelaws governing the Association unless it is voted by 3/5th of the members present at a meeting convened for the purpose and confirmed by 3/5ths of its members present at a second special meeting.

20. Minding Up:-

In case the committee has to be wound up, the property and the funds of the Association that will remain after the full satisfaction of the liapilities will be paid transferred or paid to some other institutions with similar aims and objects.

21. Suits:-The Association may sue or be sued in the name of the president.

22. Froperty:

An y judgement for the recovery of the property shall be enforced against the property of the Association only.


